3 | Privacy Statement

The structure and the storage of data fulfills the Data Protection Act of Germany (Bundesdatenschutzgesetz, BDSG). During a contract several data and personal data may be stored. The storing follows accepted encryption and safety procedures. The personal data is stored on the platform server at least as long the user has an account. The following information is included:

- Name, given name
- Password
- Email address
- Test results
- Examination results
- Statements in chatrooms or discussion or similar
- Other information that can be stored in the profile (Data input by user), e. g.: Photo, additional information, phone number, hobbies, etc.

After having finished a training provider and the operator reserve the right to delete the personal information from the server as described here:

Training course related information will be stored anonymously for statistical reasons. The link to the specific person is not given. Personal data (customer number, name, given name, email address, etc.) will be deleted after six months.

Anonymity

The anonymity of a user is not given on the platform. The provider or operator have access to all chats, user profiles and results (tests and examinations). Uploads and downloads can be linked to the user. In addition the identity of a user may be public in a classroom or chat. A user is able to publish his personal information and to make his participation visible ("user is online"). If a new user is created by the provider or operator, the email-address is invisible. It can be switched to visibility by the user.

Damages through Malware (Illegal Use)
